How to Start Using the Connections II Contract

First, a warranted Contracting Officer (CO) requests a Delegation of Procurement Authority (DPA) from GSA. The form is available online and takes approximately five minutes to fill out. GSA should issue a delegation confirmation within two business days. After receiving the confirmation, the CO becomes a Connections II Ordering Contracting Officer (OCO) and is able to issue task orders under Connections II. An OCO may issue orders directly to the contractors or use the assisted services offered by GSA regional representatives. Task orders may be for single or multiple sites as defined by the project. An agency may choose to have one or many OCOs.
